Connection Services Offer

The offer to be made by United Energy in response to this Request will include an obligation that the Developer named below will comply with the applicable clauses set out in the Distribution Code.

United Energy will issue an offer for connection services within 65 Business Days of receipt of the Request Form, signed and completed in full with the correct information, excluding the time taken by the customer to provide additional information to the written application as reasonably sought by United Energy.

If this Request Form does not contain such information as to make the offer United Energy shall seek such further information from the Developer as soon as reasonably practical.

I/We wish to carry out the construction/installation of the internal reticulation of the subdivision utilising approved contractors.

I/We wish to await advice as to United Energy's initial estimates

I/We have been advised that the following options are available to me/us upon receipt of final design and/or United Energy's initial estimate:

- That I/we may request that United Energy call tenders for undertaking augmentation work associated with the connection service.
- That I/we may waive our rights to request United Energy to call tenders and that United Energy carry out the construction/installation of the internal reticulation of the subdivision
- That I/we may carry out the construction/installation of the internal reticulation of the subdivision utilising contractors approved by United Energy.
