Clause 4.2.2(b)(i)(a)	Staff sharing is allowed where the member of staff does not have access to electricity information.
Clause 4.2.2(b)(i)(b)	Staff sharing is allowed where the member of staff has access to electricity information but does not have in performing the roles, functions or duties of their staff position, any opportunity to use that electricity information to engage in conduct contrary to DNSP's obligations under cl. 4.1 (obligation not to discriminate).
Clause 4.2.2(b)(i)(c)	Staff sharing is allowed where the member of staff only has access to electricity information to the extent that is necessary to perform services that are not electricity services (such as general administration, accounting, payroll, human resources, legal or regulatory, or IT support services).
Clause 4.2.2(d)	Staff sharing is allowed where the shared staff are officers of both the DNSP and the related electricity service provider.

The purpose of this document is to identify the nature of positions (including a description of roles, functions and duties) of its members of staff to which CitiPower/Powercor and United Energy has not applied section 4.2.2(a) of the Ring-fencing guideline (which prohibits staff of the DNSP who are involved in the provision of direct control services being also involved in the provision of contestable electricity services by a related electricity service provider). It further provides analysis of the exemptions in clause 4.2.2 as they apply to role categories. This register is publicly available on CitiPower/Powercor and United Energy's website and is updated periodically.
